



## Film Waiver

As a tribally owned and operated facility, The Stables Casino maintains the following guidelines regarding on-site filming and content creation. All individuals or groups wishing to record video, including platforms such as YouTube, TikTok, or other social media, must obtain prior written approval from casino management.

Any recording or images taken on the premises must adhere to the following standards of conduct:

- Daily notification to casino management is required before initiating any filming, recording, or documentation of activities at 530 H St. SE, Miami, OK.
- Walkthrough filming and the recording of patrons or employees is strictly prohibited. No individual or their identifiable information may be captured or included without prior written consent from us and/or the individual concerned.
- Permitted equipment is restricted to a handheld camera or smartphone, either held manually or mounted on a compact, portable base positioned between the player and the slot machine. Under no circumstances may walkways be obstructed.
- You must not interfere with or harass any players, or guests, while on the premises.
- Filming must never interfere with normal casino operations or interrupt business in any way.

Any social media posts, or other publications of any recordings or images taken on the premises, must adhere to the following standards of conduct:

- Your post and publications must comply with all applicable laws, rules, and regulations.
- You may not:
  - a. Disseminate false, inaccurate, or misleading information regarding the casino, its offerings, or individuals on the premises.
  - b. You may not publish or share any content containing images or video footage of individuals without obtaining prior written consent.
  - c. Disclose any of our confidential information.
  - d. Make derogatory or unsubstantiated statements about the casino, its events, brand identity, offerings, or services.
  - e. Engage in communications that violate the legal rights of others, including defamation, or infringement of copyright, trademark, privacy, publicity, or other intellectual property protections.

- f. You may not promote, market, or sell any product or service on behalf of the casino, nor use any of our trademarks, branding, or intellectual property without prior written authorization.
- g. Use speech or actions that create an atmosphere of hostility, intimidation, or disrespect toward others.
- h. You may not share or publish content that encourages or reflects prejudice, hate, or discriminatory views based on race, gender, religion, national origin, disability, sexual orientation, age, or other protected characteristics.
- i. Engage in the use of discriminatory, abusive, vulgar, or otherwise inappropriate language.
- j. You must not share or publish any statements or content that encourages, endorses, or incites behavior that could compromise the safety of the casino, its patrons, guests, or any individuals on the premises.
- k. You are required to comply with any supplementary directives issued by the casino regarding conduct on the premises and any related content you publish or share.
